

# **ENVIROMENTAL COMMITMENTS**

**ENVIROMENTAL COMMITMENTS:**

TECHNOFORM expects its suppliers to comply with environmental principles aligned with its corporate environmental policy.

In this context, the SUPPLIER:

1. The Supplier shall identify and comply with all applicable environmental legal and other requirements related to its contractual relationship with Technoform.
2. In the absence of a certified Environmental Management System (ISO 14001 or equivalent), the Supplier shall implement appropriate environmental protection, prevention, and control measures commensurate with the environmental aspects of the services or activities performed.
3. The Supplier shall promote the efficient use of natural resources, including water and electricity, as well as raw materials and consumables used in the performance.
4. The Supplier shall implement measures to prevent, reduce, and manage waste generation arising from its activities.
5. The Supplier shall provide the necessary means to ensure the proper management and disposal of all waste generated, including hazardous, inert, and non-hazardous waste, where generated in significant quantities. Where applicable, agreements may be established for TECHNOFORM to manage such waste, subject to compliance with TECHNOFORM's internal environmental procedures and requirements.
6. The Supplier shall inform TECHNOFORM, as soon as they are identified, of any actual or potential liquid discharges, ensuring that such discharges do not cause environmental contamination or interfere with treatment systems. Depending on the characteristics of the liquid waste generated, disposal arrangements may be assigned to the Supplier or Contractor.
7. The Supplier shall notify TECHNOFORM without undue delay of any atmospheric emissions or generation of odours, noise, or vibrations resulting from its activities that may constitute environmental pollution or pose risks to the health and safety of its own personnel or third parties, in order to enable the implementation of appropriate preventive and corrective measures.
8. The Supplier shall immediately report to TECHNOFORM any environmental incident, arising during the performance of the work, for the purpose of enabling the adoption of appropriate response, containment, and corrective actions.
9. The Supplier shall bear any costs not foreseen in the contract that are associated with the proper fulfilment of environmental obligations arising from these clauses and from applicable environmental legislation. Should TECHNOFORM incur any such costs, they shall be recoverable from the Supplier or Contractor.

10. The Supplier shall ensure that all personnel involved in the contract with TECHNOFORM are competent, appropriately trained, and aware of the environmental aspects and impacts associated with their activities, including potential incidents and emergency situations.
11. The Supplier shall hold and maintain valid all environmental permits, licenses, authorizations, or registrations required for the execution of the work. The acquisition and maintenance of such permits shall be the responsibility and at the expense of the Supplier, except where legislation assigns such responsibility to TECHNOFORM.
12. The Supplier shall be responsible for ensuring compliance with these environmental requirements by its subcontractors, where applicable, and shall ensure that such requirements are communicated and enforced throughout the supply chain.
